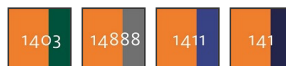

Ruler pocket. Thigh phone pocket with flap and adjustable hook and loop band fastening. Pen pockets. Kneepad pockets. We recommend 00718-100, 50451-916 & 20118-915 kneepads for this model. ## Logo

In order to maintain the product's hi-vis class according to EN ISO 20471, the instructions on logo size must be observed.

## Logo placement:

- Workwear logo. Left back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Right back pocket flap. Max 9x3 cm/3.5x1.1 inches
- Workwear logo. Right back pocket. Max 10x5 cm/3.9x1.9 inches
- Workwear logo. Horizontal on left thigh. Max 11x5 cm/4.3x1.9 inches
- Workwear logo. Vertical on right thigh, read from the top downwards. Max 15x5 cm/5.9x1.9 inches
- Workwear logo. Horizontal on right thigh. Max 11x5 cm/4.3x1.9 inches
